COURSE DESCRIPTION

This Two Day Scenario based Narcotics Operations Course has been designed for undercover operators, cover officers and support team members conducting covert narcotics, firearm and major case operations. This course focuses on the development of in-depth criminal cases utilizing confidential informants and undercover operators to identify, target and dismantled organized criminal groups and street gangs.

Highlighted are the pitfalls and officer safety issues associated with these cases and the use of confidential informants. Detailed are the specific roles and responsibilities of every team member from supervisor to undercover operator. Using a stepped approach with a concentration on mitigating risk, students are provided with the techniques and skills to achieve a positive outcome when faced with tenuous and hazardous situations. This course is presented through the use of lecture, power point presentation and actual videos of firearm and narcotics undercover operations.

- Case Studies (UC involved shooting, UC assault, UC Gun Buy from Gang Member)
- Situational Awareness - UC Do's and Dont's
- Home Invasion/Narcotic Robbery Organization Reversals
- Verbal and Non Verbal Tells
- Religious icons, shrines and rituals
- Residential and vehicle concealment
