Description:

There are approximately 400,000 human trafficking victims in the US alone. Human trafficking illicit profits are estimated to be more than \$150 billion annually. Nationally, law enforcement usually only receives the bare minimum of human trafficking training. Most training only concentrates on the “force, fraud coercion” portions of human trafficking, and not real-world examples of what it looks like in the field and or how to successfully investigate these cases. Human trafficking (HT) investigations are unique in nature since the preferred response with victims during sting-type operations is to not arrest. And this is often a hard pill for law enforcement to grasp without some discussions and more in-depth training on HT. And most human trafficking victims don’t identify themselves as “victims” due to trauma bonding and rarely cooperate with law enforcement. This one-day course will show real examples of what human trafficking looks like in the field from sex trafficking, forced labor, interdiction, gang, and drug investigations.

This one-day course covers the following:

- What the “real face” of human trafficking looks like.
- What to do and whom to include in proactive human trafficking investigations.
- Educating/working with prosecutors.
- Non-governmental organizations.
- Undercover selections/decoys.
- Electronic surveillance equipment.
- Proactively doing in-call & outcall prostitution/human trafficking operations (manpower, money, locations, electronic evidence, etc.).

- Illicit massage parlor investigations/OSINT.
- Forced labor investigations.

Instructor: William "Bill" Loucks Jr

Bill is currently the North Carolina senior investigator for Hope For Justice, where he conducts human trafficking investigations for a non-governmental organization (NGO).

Bill retired from the Metro Nashville Tennessee Police Department in August 2018. Bill spent 13 of his 15 1/2 years with Metro PD working as a gang and narcotics detective. Throughout his time with Metro PD, Bill had written more than 800 search warrants and been involved in more than 1000 search warrant executions. He has been the affiant on and taken part in multiple T-III (wiretap) cases. Bill has more than 17,000 Hrs. and 10 years of investigative experience ranging from transnational criminal organizations (TCO/cartel), street dealers, organized crime, homicides, weapons violations, fraud rings, and identity theft.
